Seals Against Oil, Water and Salt – STAIN-PROOF reduces the surface energy of stone below the surface tension of oil and water. These liquids then do not enter the surface and are not pulled into the stone or concrete through capillary action. STAIN-PROOF is also an excellent graffiti repellent.

Better Chemistry – STAIN-PROOF's minute silane molecule penetrates the stone deeply in an alcohol-based liquid instead of a petroleum distillate. A chemical reaction bonds the silane molecule to the latticework of the stone forever. Nothing can break this chemical bond, including ultraviolet light. Silanes are different from the molecular fillers of the siloxane family, commonly used in other sealers. Siloxanes (and Teflons used in other sealers) wear out and must be reapplied.

Long Life Indoors or Out – The deep penetration (typically 1/4") combined with the permanent chemical bonding allows us to offer a written 15-year performance warranty stating the stone will remain hydrophobic and oleophobic when STAIN-PROOF is applied by an Accredited Applicator and cleaned regularly.



Apply Even with Damp Substrate – STAIN-PROOF is completely “breathable.” While preventing oils, water and salt from penetrating the stone, it allows water *vapor*

to pass outwards through the stone surface. If the mortar bed or thinset is damp during installation, it will dry out. Because it is “breathable,” STAIN-PROOF will prevent efflorescence. Incidentally, STAIN-PROOF passes through all other water-based or solvent-based impregnating sealers.

Use Any Cleaner – STAIN-PROOF won't change the frictional properties or appearance. It makes cleaning much easier by holding liquids on the surface for cleaning with detergent. STAIN-PROOF is bleach-tolerant, so surface marks can often be bleached away. In fact, any cleaner can be used without affecting the seal. Please note: acidic cleaners may etch the stone, though they do not affect the seal.

Easy to Apply – STAIN-PROOF is easy to apply. Spread on the surface so it looks like a mirror finish for at least 3 seconds and allow it to penetrate for 10 minutes or more. Repeat with a second coat. Wipe off any excess with a clean white cloth while it is still wet. Use stone after 6 hours.

Protect Granite Countertops from Oil and Water Stains – STAIN-PROOF Plus – While STAIN-PROOF works on all natural stone, including most marble and granite, occasionally the higher concentration of STAIN-PROOF Plus provides the best protection against oil and water on a dense granite countertop. Warranty: 25 years.

Protect Natural Stone from Oil, Water and Salt (Water-Based) – META-CREME – Seals natural stone, grout, concrete and pavers against oil and water-based stains. No-smell lotion never needs reapplication. Stands up to all cleaners. Low-VOC. LEED Compliant. Warranty: 15 years.

Performs as well and lasts as long as competing water-based products at a lower price. Duration of protection will vary based on environment and cleaning process.

Consolidate Natural Stone or Concrete – Dry-Treat 40SK Consolidator – Whether age, salt or freeze-thaw cycles has caused concrete or natural stone to begin to disintegrate, Dry-Treat 40SK Consolidator can strengthen loose and friable surfaces. Suitable for concrete and soft stone such as sandstone. Also protects against water and salt penetration. Warranty: 15 years.

Safely Clean Natural Stone and Grout – Hanafinn Rejuvenata Active, Hanafinn Oxy-Klenza – Safe cleaners for use on all natural stone. Rejuvenata Active is a concentrated enzymatic cleaner to remove oils, organic materials and mold. Oxy-Klenza is a powdered, activated oxygen, alkaline cleaner suitable for cleaning organic stains from stone surfaces.
